

Bosnia and Herzegovina for all of us!¹

At the advanced workshop "Harnessing the Power of Cooperation" held in Jajce in the period 20-22 November 2020 on the occasion of the 25th anniversary of the establishment of the General Framework Agreement for Peace in Bosnia and Herzegovina, which was attended by students from Banja Luka, Bijeljina, Brčko, Mostar, Sarajevo and Tuzla, the proposals how to improve the system of governance at different levels in the following areas were adopted:

- 1) We advocate a firm commitment of Bosnia and Herzegovina to respect European values and ideas, as well as to harmonize legal regulations with the European Union laws, and we encourage the strengthening of regional cooperation (support for the "Mini Schengen" initiative) and bilateral relations.
- 2) Recognizing the contribution of the General Framework Agreement for Peace in Bosnia and Herzegovina in stopping the armed conflict and establishing a democratic order, we believe that the time has come to correct the shortcomings of the Annex IV, ie the Constitution of Bosnia and Herzegovina, in implementing all relevant judgments of the Constitutional Court of Bosnia and Herzegovina, and the European Court of Human Rights. In this way, we affirm the constitutivity of the people as a fundamental principle of the Constitution, but it also enables all citizens of Bosnia and Herzegovina, including the citizens of the Brčko District, to vote and be elected for all levels of government.
- 3) We stand for the full realization of all political rights for all citizens of Bosnia and Herzegovina, and the legitimate representation of the people as the foundation of the future of Bosnia and Herzegovina.
- 4) We are committed to the realization of the principles of national (*original – narodne*) and state sovereignty and its operation within each of the three branches of government. We oppose the practice of displacing relevant decision-making from the institutions of Bosnia and Herzegovina, which is a denial of the importance of the meaningful democratic political systems.
- 5) We want the governments at all levels to work in the interest of the citizens of Bosnia and Herzegovina.
- 6) Recognizing corruption as one of the urgent matters in society, we call for a systematic fight against corruption and organized crime in all parts of society. Competent institutions in charge of eradicating corruption must take decisive steps through all available mechanisms and using positive examples.
- 7) Economic reforms as the basis of economic self-sustainability is in the common interest of all citizens and in the interest of an independent and sovereign state. We are convinced that reducing taxes for new investments, including those from the diaspora, would lead to improved conditions for the development of the domestic market. Domestic production can be improved by providing incentives to the real sector.
- 8) It is necessary to reform the existing public administration in order to implement the principle of meritocracy, according to the principle that professional functions are given to professionals without taking into account their political affiliation. It is also necessary to implement new norms and laws that would prevent party and political employment.
- 9) The education system in Bosnia and Herzegovina needs to be harmonized with the best world standards. We strongly oppose the elements of segregation and discrimination in education systems. It is high time that the education system responds to the needs of the labor market, and that the labor market enables students to gain practical experience. We advocate for enabling talented individuals and professionals, both

domestic and those who have left the country, to play an active and advisory role in education reform in Bosnia and Herzegovina. We encourage pupils and students, as well as the management of educational institutions, to participate even more and support student exchange programs, both within Bosnia and Herzegovina and outside the borders of Bosnia and Herzegovina. We believe that complete freedom is necessary in teaching and scientific research, and artistic creation without the interference of public authorities in the implementation of scientific and teaching processes.

10) Young people have identified two key problems of leaving Bosnia and Herzegovina, namely political and socio-economic instability. We urge the competent authorities to come out with concrete measures towards young people that will prevent further departure and promote their active return.

11) We agree that it is necessary to depoliticize the media, especially public service media. We call on regulatory bodies to take a stronger and more active role in meeting their legal obligations by ensuring effective mechanisms that will enable objective and impartial reporting in public media services in Bosnia and Herzegovina.

12) The reform of the health sector should ensure the improvement of primary health care service and lead to the creation of satisfactory conditions for the work of medical staff. We demand that health care be provided to all citizens of Bosnia and Herzegovina in any part of the territory of Bosnia and Herzegovina if they have adequate insurance from one of the health insurance institutes.

13) We emphasize the need to improve the supervisory system in the election process, and the introduction of electronic vote scanning.

14) It is necessary to introduce the e-citizen system (use of digitalization and e-platforms) in order to reduce administrative costs, administrative apparatus, and to ensure better efficiency of the public sector.

15) It is the duty of all of us to provide future generations with the same or better conditions in which they will be able to develop and live in a healthy environment. We want Bosnia and Herzegovina to be able to preserve all its landscapes and natural resources so that they are accessible to both the citizens of Bosnia and Herzegovina and foreigners. We demand compliance with and stricter regulations that:

- Protects all forest and biological areas,
- Strictly punishes improper disposal of waste,
- Supports recycling and the use of biodegradable materials (ecological waste management),
- Protects water surfaces from pollution and destruction,
- Regulates strategic planning during the construction of infrastructure facilities, with the involvement of the local community in making the best decisions,
- Improve air and food quality,
- Defines better the conditions for granting concessions on natural resources and goods.

We hope that the period ahead will be marked by stability, visible economic growth and the well-being of all the inhabitants of Bosnia and Herzegovina.

Bosna i Hercegovina za sve nas!

Na naprednoj radionici „Korištenje snage saradnje“ održanoj u Jajcu u periodu 20.-22.11.2020. godine, a povodom 25. godišnjice od uspostavljanja Opšteg okvirnog sporazuma za mir u Bosni i Hercegovini, u kojoj su učestvovali studenti iz Banje Luke, Bijeljine, Brčkog, Mostara, Sarajeva i Tuzle, usvojeni su prijedlozi za unapređenje sistema različitih nivoa vlasti u sljedećim oblastima:

- 1) Zalažemo se za čvrsto opredjeljenje Bosne i Hercegovine ka poštivanju evropskih vrijednosti i ideja, kao i ka usklađivanju pravnih propisa sa pravom Evropske Unije, te ohrabujemo osnaživanje regionalne saradnje (podrška inicijativi „Mini šengena“) i bilateralnih odnosa.
- 2) Uvažavajući doprinos Opšteg okvirnog sporazuma za mir u Bosni i Hercegovini u zaustavljanju oružanog sukoba i uspostavljanju demokratskog poretka, vjerujemo da je došlo vrijeme za ispravljanje manjkavosti Aneksa IV, odnosno Ustava Bosne i Hercegovine, u segmentu sprovođenja svih relevantnih presuda Ustavnog suda Bosne i Hercegovine, te Evropskog suda za ljudska prava. Na taj način, potvrđujemo konstitutivnost naroda kao temeljnog načela Ustava, ali takođe se omogućuje da svi građani Bosne i Hercegovine, uključujući građane Brčko Distrikta, mogu birati i biti birani za sve nivoe vlasti.
- 3) Zalažemo se za potpuno ostvarivanje svih političkih prava za sve građane Bosne i Hercegovine, i legitimno predstavljanje naroda kao temelj budućnosti Bosne i Hercegovine.
- 4) Privrženi smo ostvarivanju načela narodne i državne suverenosti i njenog djelovanja unutar svake od tri grane vlasti. Suprotstavljamo se praksi izmještanja donošenja relevantnih odluka iz institucija Bosne i Hercegovine, što predstavlja negiranje značaja smisla demokratskog političkog sistema.
- 5) Želimo da vlast na svim nivoima radi u interesu građana Bosne i Hercegovine.
- 6) Prepoznajući korupciju kao jedan od gorućih problema u društvu pozivamo na sistematsku borbu protiv korupcije i organizovanog kriminala u svim porama društva. Nadležne institucije koje su zadužene za iskorjenjivanje korupcije moraju preduzeti odlučne korake putem svih dostupnih mehanizama i koristeći se uspješnim primjerima praksi.
- 7) U zajedničkom interesu svih građana je ekonomska reforma kao osnov ekonomske samoodrživosti, te ekonomski nezavisne i suverene države. Uvjereni smo da bi smanjenje poreza i doprinosa za nove investicione cikluse, uključujući i one iz dijaspore, dovelo do poboljšanja uslova za razvoj domaćeg tržišta. Domaću proizvodnju je moguće unaprijediti pružanjem stimulacija realnom sektoru.
- 8) Neophodna je revizija postojeće javne uprave u cilju implementacije načela meritokracije, po ključu da profesionalne funkcije dobijaju stručna lica ne uzimajući u obzir njihovu političku pripadnost i implementacija novih normi i zakona radi sprečavanja stranačkog i političkog zapošljavanja lica na stručne funkcije.
- 9) Obrazovni sistem u Bosni i Hercegovini potrebno je usklađivati sa najboljim svjetskim standardima. Snažno se protivimo elementima segregacije i diskriminacije u obrazovnim sistemima. Krajnje je vrijeme da obrazovni sistem odgovori potrebama tržišta rada, te da tržište rada omogući sticanje praktičnog iskustva učenicima i studentima. Omogućiti nadarenim pojedincima i stručnjacima, kako domaćim, tako i onim koji su napustili zemlju, da imaju aktivnu i savjetodavnu ulogu u reformi obrazovanja u Bosni i Hercegovini. Ohrabujemo učenike i studente, te rukovodstva obrazovnih institucija, da još više učestvuju i podrže programe razmjena učenika i

studenta, kako unutar Bosne i Hercegovine, tako i izvan granica Bosne i Hercegovine. Smatramo da je neophodna potpuna sloboda u nastavnom i naučnoistraživačkom radu, te umjetničkom stvaralaštvu bez miješanja javnih vlasti u izvođenju naučno-nastavnih procesa kao temelj slobodne misli, obrazovnog i naučnog napretka.

- 10) Mladi su identifikovali dva ključna problema odlaska iz Bosne i Hercegovine a to su politička i socio-ekonomska nestabilnost. Urgiramo prema nadležnim vlastima da prema mladim ljudima izađu sa konkretnim mjerama koje će dovesti do sprečavanja daljeg odlaska i promovisati aktivan povratak istih.
- 11) Saglasni smo da je neophodno pristupiti depolitizaciji medija naročito na javne medijske servise. Pozivamo regulatorna tijela da preuzmu snažniju i aktivniju ulogu u ispunjavanju svojih zakonskih obaveza na način da osiguraju efikasne mehanizme koje će omogućiti objektivno i nepristrasno izvještavanje u javnim medijskim servisima u Bosni i Hercegovini.
- 12) Reforma zdravstvenog sektora treba da osigura poboljšanje primarne zdravstvene zaštite i dovede do stvaranja zadovoljavajućih uslova za rad medicinskog osoblja. Zahtijevamo da se omogući zdravstvena skrb svim građanima Bosne i Hercegovine na bilo kom dijelu teritorije Bosne i Hercegovine ukoliko posjeduju odgovarajuće osiguranje jednog od zavoda za zdravstveno osiguranje.
- 13) Naglašavamo potrebu unapređenja nadzornog sistema u izbornom procesu , te uvođenja elektronskog skeniranja glasova.
- 14) Potrebno je uvesti sistem e-građanin (upotreba digitalizacije i e-platformi) radi smanjenja administrativnih troškova, administrativnog aparata, te bolje učinkovitosti javnog sektora.
- 15) Dužnost svih nas jeste da budućim naraštajima obezbijedimo iste ili bolje uslove u kojima će moći da se razvijaju i žive u zdravoj životnoj sredini. Želimo Bosnu i Hercegovinu koja će uspjeti da sačuva sve svoje ljepote i prirodne resurse da bi isti bili pristupačni kako građanima Bosne i Hercegovine, tako i dobronamjernim posjetiocima. Zahtijevamo poštovanje i pooštavanje propisa kojima se:
 - Štite sva šumska i biološka područja,
 - Strogo kažnjava nepropisno odlaganje otpada,
 - Podržava segment reciklaže i korištenje biorazgradivih materijala (ekološko upravljanje otpadom),
 - Štite vodene površine od zagađenja i uništenja,
 - Reguliše strateško planiranje prilikom izgradnje infrastrukturnih objekata, uz uključivanje lokalne zajednice u donošenju najboljih odluka,
 - Unapređuju nivoi zaštite kvaliteta vazduha i hrane,
 - Bolje definišu uslovi davanja koncesija na prirodne resurse i dobra.

Nadamo se da će period pred nama biti obilježen stabilnošću, vidljivim ekonomskim rastom te blagostanjem svih stanovnika Bosne i Hercegovine.
